



## Rules of IrriSarri Land Bike Park

The IrriSarri Land Bike Park is designed for mountain biking enjoyment in a natural environment. To ensure everyone's safety, please follow these rules:

### Safety and Environment

- **Natural environment:** The Bike Park is located in a natural setting with native flora and fauna. Respect the environment, trails, and animals.
- **Obstacles:** The park is regularly maintained, but natural obstacles like branches and rocks may still be present. If you encounter dangerous obstacles while riding, avoid them and inform the Bike Park staff so they can be removed.
- **Signage:** Follow the park signage and the indicated riding directions.
- **Animals:** If you come across animals on the trails, do not disturb them; allow them to move away calmly.
- **Maintenance:** Do not modify the trails. Any modifications must be carried out by authorized IrriSarri Land staff.

### Equipment and Protection

- **Mandatory protective gear:** Wearing a helmet and knee pads is required.
- **Recommended protective gear:** The use of elbow pads, a chest protector, and goggles is recommended.
- **Bicycle condition:** Your bicycle must be in perfect mechanical condition and suitable for downhill riding.

### Access and Age Restrictions

- **Under 18 riders:** Riders under 18 must present a signed authorization from a legal guardian:
  - As the responsible party during the activity.
  - Allowing the minor to participate in the activity independently under their own responsibility.
- **Dirt Park and Pump Track:** The same age restrictions apply as in the main Bike Park.

### Insurance

*If you've hired your forfait WITH insurance.* The insurance shall be in effect only on the day on which it is contracted, and may not be part of any event beyond the date. It includes coverage in the costs of the injured person for the use of the most

suitable means of transport to follow the most appropriate treatment, at the discretion of the doctor or equipment that attends him, up to the prescribed Hospital Center up to the limit of € 1,000.

*If you've hired your forfait WITHOUT insurance.* In the event of an accident, you will not have any insurance included and you must inform your insurer, federation or take care of all the costs.

### Behavior in the Park

- **Speed control:** Adapt your speed according to your skill level and terrain conditions.
- **Overtaking:** Pass other riders cautiously and notify them before overtaking.
- **Stopping:** Stop only in designated areas and off the trails.
- **Respect:** Be respectful to other users and avoid any behavior that could endanger others.
- **Prohibited actions:**
  - Riding under the influence of alcohol or drugs.
  - Riding in the opposite direction of the trails.
  - Damaging park facilities or signage.
  - Filming or taking photos for commercial purposes without permission.

### Activity Enjoyment Clause

The activity is considered fully enjoyed once the participant:

- **Enters the premises:** Once the participant arrives at the designated meeting point and begins receiving instructions from the guide or instructor, the activity is considered to have begun and therefore has been enjoyed.
- **Starts the activity:** For activities conducted outside our facilities, the activity is considered to have been enjoyed once the participant starts it under the guide's supervision.
- **Fails to show up:** If a participant does not show up at the scheduled time and location without prior notice or justified cause, it will be considered as a voluntary forfeiture, and the activity will be deemed enjoyed.
- **Interrupts the activity:** If the participant decides to stop the activity after it has



started for personal reasons, no refund will be issued.

**Weather Conditions**

Activities will take place regardless of weather conditions unless they pose a safety risk to participants. In the event of adverse weather conditions preventing safe participation, the following options will be offered:

- **Reschedule the activity:** At no additional cost, provided conditions allow.
- **Switch to another activity:** If alternative activities are available.

**Responsibility**

- **Risk awareness:** Mountain biking is a high-risk sport. Each rider is responsible for their own safety and must assess their abilities before attempting any trail.
- **Liability waiver:** The park is not responsible for accidents or injuries resulting from improper use of facilities or lack of rider ability.
